## COPYRIGHT AND REPRODUCTION: PHOTOGRAPHS, POSTERS, SCRIPTS, AND ARCHIVAL DOCUMENTS

The Cinémathèque québécoise (CQ) has many photographs and posters, as well as archival documents, such as scenarios, for which it is not the rights-holder. Obtaining permission or a licence to reproduce such items from the rights-holders is always the responsibility of the licensee, who must subsequently show proof of permission or licence possession.

Requests to obtain copies of archival documents for any type of publication must be submitted in writing to the Media Library (Médiathèque Guy-L. Coté) at least 10 working days prior to desired access and contain the following information:

The name, address, and telephone number of the licensee, as well as a description of use of the requested document(s). Permission to reproduce must be authorized by the Director of Collections. A request may be denied if the stated use is judged to be inappropriate or disrespectful of the copyright or the moral right of the author. A request may also be denied if the donor has restricted access to certain documents. Archival documents must come from collections or donated collections for which the donors have granted copy and publishing rights.

All reproduced or published documents must include a bibliographical notice supplied by the Media Library, specifying the following:

- The document comes from the Cinémathèque québécoise.
- The complete name of the collection or the donated collection.
- The ID number or the accession number.

Other information to be included in the published document can be added if necessary, such as a photo credit, copyright notice or author's copyright specifications.

The Cinémathèque requires that all documents from its collections be reproduced respecting their integrity and the moral rights of the author. In cases where the CQ is the rights-holder of photographs or other documents in its collections, aside the reproduction fees, (schedule A) an additional fee for the license will be charged (schedules B or C).

Aside from these fees, additional costs can be added if the CQ personnel pre-selects the material for the client or if the CQ has to transport documents or artifacts from its vault to Montreal. In such cases, additional costs of $\$ 100 /$ hour (1 hour minimum) apply.
